Highland Middle School Renovation Project

Preliminary Building Aesthetics Presentation was given by Dan Engen, VEBH, Architect

- Mr. Engen talked about the preliminary concepts that will give meaning to the building. The
 concept connects to the curriculum and also connects the current HMS to the new building.
 The three concepts are: Explorers (6th grade), Inventors (7th grade), and Pioneers (8th grade).
